ORDER:

The State Government have decided to establish a District Delivery Unit to provide management support to District collectors by providing Rs.1.00 crore to each district towards consultancy fee to Mission experts to achieve double digit growth.

2. The Finance (EBS-I-GAD-I-II) Department have issued the Budget Release Order (BRO) in the G.O. read above for an amount of Rs.13.00 crore (Rupees thirteen Crore only) under Plan from BE provision 2015-16 in relaxation of quarterly regulation towards meeting the expenditure under the scheme "Consultancy Fees for Mission Experts" with the Head of Account 3451-090-11-39-280-284 at the rate of Rs.1.00 crore (Rupees One Crore only) per district for the financial year 2015-16.

3. In pursuance of the orders issued in the reference read above, Government hereby accord administrative sanction and release Rs.13.00 crore (Rupees thirteen Crore only) for providing management support to all the District Collectors in the state. Detailed guidelines will be issued for the utilization of released funds.

4. The amount sanctioned in para-3 above shall be debited from the scheme "Consultancy Fees for Mission Experts" with the Head of Account 3451-090-11-39-280-284. The District Treasury Officers concerned are requested to draw and credit the amount to the PD Account directly under the Head of Account "8448-Deposits to Local Funds–MH-120-Other Funds- SH(22)- Deposits of the Decentralized Planning".

5. All the District Collectors concerned are authorized to draw and incur expenditure towards consultancy charges to the mission experts.
